Purpose. The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, including changes to these policies, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families

Applicability. The Form HUD-50075-HCV is to be completed annually by **HCV-Only PHAs**. PHAs that meet the definition of a Standard PHA, Troubled PHA, High Performer PHA, Small PHA, or Qualified PHA do not need to submit this form. Where applicable, separate Annual PHA Plan forms are available for each of these types of PHAs.

Definitions.

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers, and was designated as a high performer on both the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments if administering both programs, or PHAS if only administering public housing.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceed 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceed 550, and that was designated as a standard performer in the most recent PHAS and SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined and is not PHAS or SEMAP troubled.

Progress Report.

MISSION - The Taylor Housing Commission will create and provide decent, safe, quality affordable housing to low and moderate income families and, in developing mixed income communities will enhance and promote individual opportunity, help achieve Family Self-Sufficiency and stability in healthy, dynamic and diversified neighborhoods.

A key goal was accomplished in 2016 – conversion of PH units thru RAD to Project Based Vouchers.

PHA Goal: Expand the supply of assisted housing

Objectives:

Apply for additional rental vouchers: - THC has increased its Voucher portfolio from 408 to 1093 and has leased up to 93%.

THC has adopted Project Based Vouchers for PH conversion and has implemented effective Dec 2016. The PBV are leased up to 98%, pre pandemic and the impact of the pandemic has contributed to drop in the lease up rate to 91%. THC is begun to take steps to increase the lease up rate to average of 98%.

Leverage private or other public funds to create additional housing opportunities: - THC has adopted in its Annual Plan to provide project based vouchers through partnership with private entities/properties.

THC plans to absorb Voucher Program units of other PHA's that are willing to participate in consolidation and manage an effective and cost efficient program.

THC plans to evaluate and apply to Moving To Work (MTW) program that benefits families in moving more towards self-sufficiency.

PHA Goal: Improve the quality of assisted housing

Objectives:

Improve voucher management: (SEMAP score) To sustain current standards and focus on continuous improvement - THC has moved from being a troubled agency to a HIGH PERFORMER. For the past five years THC has consistently maintained its standards of performance and being responsive to HUD's requirements. THC consistently maintains 90%+ leasing rate.

Increase customer satisfaction: THC hosts periodic meetings with residents to discuss concerns, modernization activities, program changes, maintenance issues, and tenant holiday activities.

Concentrate on efforts to improve specific management functions: - With the assistance of a Management Consultant THC has improved many of its management functions such as operations, leasing, maintenance, implementation of Capital Fund Programs on a timely basis, conversion of PH to RAD, and policy updates.

Provide continuous training to staff; - THC administration staff is fully certified for the Housing Choice Voucher Program and in Occupancy and Rent Determination. Online training opportunities are provided for staff to enhance knowledge in programs.

Increase operational efficiencies;- THC with a small staff of ten and assistance from the Management Consultant manages the entire section 8 Housing Choice Voucher programs maintaining 90% - 95% leasing.

Implement effective cost controls:

PHA Goal: Increase assisted housing choices

Objectives:

Conduct outreach efforts to potential voucher landlords: THC has increased its landlord base from 408 vouchers to 1093 vouchers.

Increase voucher payment standards: THC has managed its payment standards to balance the budget and still meet the needs of the families. The payment standards are reviewed annually and are kept at or below the Fair Market Rent.

VAWA Policy

THC has adopted the Violence Against Women Act (VAWA) Policy. The purpose of this policy (herein called “Policy”) is to implement the applicable provisions of the Violence Against Women and Department of Justice Reauthorization Act of 2013 (VAWA 2013) and more generally to set forth the Taylor Housing Commission’s (THC) policies and procedures regarding domestic violence, dating violence, and stalking, as hereinafter defined.

The Violence Against Women Reauthorization Act of 2013 (VAWA 2013) expands housing protections for victims of domestic violence, dating violence, sexual assault or stalking. Changes under VAWA 2013 include extending protections to survivors of sexual assault; allowing survivors who remain in the unit to establish eligibility or find new housing when a lease is bifurcated; providing survivors with emergency transfers; and additional notification to applicants and tenants of housing rights under VAWA.

The VAWA Policy shall be applicable to the administration by the THC of all federally subsidized Project Based Vouchers and Section 8 rental assistance vouchers under the United States Housing Act of 1937 (42 U.S.C. §1437 et seq.). Notwithstanding its title, this policy is gender-neutral, and its protections are available to males who are victims of domestic violence, dating violence, or stalking as well as female victims of such violence.

strategies designed to address contributing factors, related fair housing issues, and goals in the applicable Assessment of Fair Housing consistent with 24 CFR 5.154 in a reasonable manner in view of the resources available; (iv) works with jurisdictions to implement any of the jurisdiction's initiatives to affirmatively further fair housing that require the PHA's involvement; (v) operates programs in a manner consistent with any applicable consolidated plan under 24 CFR part 91, and with any order or agreement, to comply with the authorities specified in paragraph (o)(1) of this section; (vi) complies with any contribution or consultation requirement with respect to any applicable AFH, in accordance with 24 CFR 5.150 through 5.180; (vii) maintains records reflecting these analyses, actions, and the results of these actions; and (viii) takes steps acceptable to HUD to remedy known fair housing or civil rights violations. impediments to fair housing choice within those programs; addresses those impediments in a reasonable fashion in view of the resources available; works with the local jurisdiction to implement any of the jurisdiction's initiatives to affirmatively further fair housing; and assures that the annual plan is consistent with any applicable Consolidated Plan for its jurisdiction. (24 CFR §903.7(o)).

C.4 Challenged Elements. If any element of the Annual PHA Plan or 5-Year PHA Plan is challenged, a PHA must include such information as an attachment to the Annual PHA Plan or 5-Year PHA Plan with a description of any challenges to Plan elements, the source of the challenge, and the PHA's response to the public.

D. Affirmatively Furthering Fair Housing (AFFH).

D.1 Affirmatively Furthering Fair Housing. The PHA will use the answer blocks in item D.1 to provide a statement of its strategies and actions to implement each fair housing goal outlined in its accepted Assessment of Fair Housing (AFH) consistent with 24 CFR § 5.154(d)(5) that states, in relevant part: "To implement goals and priorities in an AFH, strategies and actions shall be included in program participants' ... PHA Plans (including any plans incorporated therein) ... Strategies and actions must affirmatively further fair housing ...". Use the chart provided to specify each fair housing goal from the PHA's AFH for which the PHA is the responsible program participant – whether the AFH was prepared solely by the PHA, jointly with one or more other PHAs, or in collaboration with a state or local jurisdiction – and specify the fair housing strategies and actions to be implemented by the PHA during the period covered by this PHA Plan. Until such time as the PHA is required to submit an AFH, the PHA will not have to complete section D., nevertheless, the PHA will address its obligation to affirmatively further fair housing in part by fulfilling the requirements at 24 CFR 903.7(o)(3) enacted prior to August 17, 2015, which means that it examines its own programs or proposed programs; identifies any impediments to fair housing choice within those programs; addresses those impediments in a reasonable fashion in view of the resources available; works with local jurisdictions to implement any of the jurisdiction's initiatives to affirmatively further fair housing that require the PHA's involvement; and maintain records reflecting these analyses and actions. Furthermore, under Section 5A(d)(15) of the U.S. Housing Act of 1937, as amended, a PHA must submit a civil rights certification with its Annual PHA Plan, which is described at 24 CFR 903.7(o)(1) except for qualified PHAs who submit the Form HUD-50077-CR as a standalone document.

This information collection is authorized by Section 511 of the Quality Housing and Work Responsibility Act, which added a new section 5A to the U.S. Housing Act of 1937, as amended, which introduced the Annual PHA Plan. The Annual PHA Plan provides a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, and informs HUD, families served by the PHA, and members of the public for serving the needs of low- income, very low- income, and extremely low- income families.

Public reporting burden for this information collection is estimated to average 6.02 hour per response, including the time for reviewing instructions, searching existing data sources, gathering and maintaining the data needed, and completing and reviewing the collection of information. HUD may not collect this information, and respondents are not required to complete this form, unless it displays a currently valid OMB Control Number.
